I, _____ (Name), hereby on behalf of _____ (Name of housing estate/building), undertake to participate in the “Promotion Programme on Source Separation of Waste” organized by the Environmental Campaign Committee (ECC) with full consent and support from the majority of residents in our estate/building, and to abide by the following provisions:

1. Upon successful enrolment in the “Promotion Programme on Source Separation of Waste”, our housing estate/building will **automatically become the participant in the “Programme on Source Separation of Domestic Waste” (SSDW) launched by the Environmental Protection Department (EPD).** Details of the SSDW could be found at the Hong Kong Waste Reduction Website: http://www.wastereduction.gov.hk/en/household/source_intro.htm;
2. Our estate/building accepts the waste separation bins presented by the ECC on a free-of-charge basis. We **agree to place the waste separation bins at noticeable and accessible area(s) within the domain of our estate/building to provide a waste separation facility for the residents for at least three years.** Our estate/building will ensure the cleanliness, hygiene and maintenance of the waste separation bins, and **arrange collection of recyclable materials for recycling with cleansing contractors or recyclers**; and
3. Under any circumstances, our estate/building will not abandon the waste separation bins, nor place them outside our domain. We will implement appropriate measures to prevent malicious damage of the waste separation bins. If the waste separation bins are no longer usable due to natural wear and tear, we will arrange a recycler to collect the bins for recycling in a proper way.

本人 _____ (姓名) 謹代表 _____ (屋苑/大廈名稱) 聲明已經獲得大部份屋苑/大廈住戶同意及支持，決定參加由環境運動委員會(環運會)主辦的「廢物源頭分類推廣計劃」，並承諾會遵守以下各項細則：

- (一) 一經成功參加「廢物源頭分類推廣計劃」後，本屋苑/大廈將**自動成為由環境保護署(環保署)舉辦的「家居廢物源頭分類計劃」的參加者。**有關「家居廢物源頭分類計劃」的詳情，請參閱香港減廢網站：http://www.wastereduction.gov.hk/tc/household/source_intro.htm；

- (三) 本屋苑/大廈承諾不會以任何理由，將所獲贈的回收桶轉移到屋苑/大廈以外的地方或隨意丟棄，並會執行適當的措施，防止分類回收桶被惡意破壞。如回收桶因自然耗損致不能使用，本屋苑/大廈會安排廢物回收商妥善回收該等回收桶。

Notes

- 1) The participating estates may normally be given at most one set of waste separation bins for each block of residential building, or for every 50 households served for villa-type residential developments. If the number of waste separation bins applied is more than aforesaid, the applicant may need to provide more information for consideration.
- 2) The participating estates are not allowed to place the waste separation bins, which are distributed under this Programme, at floor areas (including staircase landing, floor refuse storage room/refuse chute room, floor cleaner room/water meter room, floor service lift lobby and floor passenger lift lobby, etc.).
- 3) It is entirely within the ECC's discretion to decide whether and how many waste separation bins will be distributed to each applicant.
- 4) Specifications of waste separation bins:

Indoor (Made of Metal)

One set with three compartments:
In total, 1m (w) x 0.4m (d) x 0.9m (h)

Outdoor (Made of Plastic)

One set of three individual bins:
Each 0.5m (w) x 0.4m (d) x 1.1m (h)

- 1) 參加的屋苑/大廈一般可獲發每座住宅樓宇一套分類回收桶，或如為別墅式住宅，最多每 50 戶一套分類回收桶。如申請回收桶數量多於前述分配，申請機構或需提供更多資料予本會考慮。
- 2) 參加的屋苑/大廈不得在大廈樓層範圍內 (例如: 樓梯平台、樓層垃圾儲存室/垃圾槽室、樓層清潔室/水錶室、樓層送貨升降機門廊以及樓層客用升降機門廊) 擺放在此計劃下所派發的分類回收桶。
- 3) 環運會保留審批申請及分配分類回收桶數目的最終決定權。
- 4) 分類回收桶尺寸規格：

室內 (金屬製)

一套，內分三格：
共 1 米(闊) x 0.4 米(深) x 0.9 米(高)

戶外 (塑膠製)

一套，包括三個獨立的回收桶：
各 0.5 米(闊) x 0.4 米(深) x 1.1 米(高)
